PRODUCT DESCRIPTION

Black primer for Jeger Beton Black decorative effect. Evens out the absorbency of the substrate, strengthens and increases the adhesion of the decorative effect....

APPLICATION

Preparation of substrate in order to strengthen and increase adhesion under effect

Decorative Jeger Concrete.

SUBSTRATE PREPARATION

The substrate should be dry, clean and durable. Remove any damaged (e.g. flaking and cracked) coating of previous paints, adhesive and lime paints. Fill surface defects with a suitable filler and sand down. Clean previously painted surfaces of any impurities that may hinder paint adhesion, e.g. dust, greasy stains, rust, fungus and mould.

PRODUCT PREPARATION

- ✓ The primer should be mixed before use.
- ✓ Do not mix with other products.
- ✓ Do not dilute with water.

APPLICATION

Methods: roller

Apply the primer with a roller. Apply at +8°C to +25°C, relative humidity max. 82%, avoid draughts. Allow to dry for 4 hours. After this time the surface can be covered with a decorative effect. Wash the tools with warm water after use.

DRYING TIME

At +23°C and 50% relative humidity, the primer is dry to the touch after approx. 4 hours. Low temperatures, increased humidity and poor ventilation prolong the drying time.
